2016 HDC FUNDRAISER SCOTCH DOUBLES TOURNAMENT RULES

- The HDC Fundraiser Scotch Doubles Tournament is NOT a USBC Certified tournament.
- This tournament is a Scotch Doubles Tournament, consisting of 3 games on the same pair of lanes. Teams can consist of 2 women, 2 men, or mixed.
- Scotch Doubles format will be used: Partner #1 throws the first ball. Partner #2 shoots the spare. If Partner #1 gets a strike, then Partner #2 throws the first ball of the next frame, and Partner #1 will shoot the spare, and so on.
- Handicap will be 425 minus the teams average multiplied by 80% then divided in half as each team member only bowls 1/2 game each.
 - In a case of a tie for prize positions, there will be a 9th & 10th frame roll-off, or the two positions will split money evenly if both parties agree.
- Entering averages for the tournament shall be as follows:
 - The highest Book Average of 2014/2015
 - If no book average, current highest average of 2015/2016.
 - If there is no book or current average then an entering average of 175 (men) / 140(women) shall be assigned.
- Averages must be from 10-pin standard

competition.

- Averages will be verified by tournament management and failure to report correct average will result in team disqualification and will forfeit all prize monies won.
- Prize monies shall be awarded within 30 days of the completion of the tournament by check and payout will be based on number of entries.

- Entries will be accepted through the day of the fundraiser/tournament on Jan. 16th, 2016.
- Bowlers shall be allowed 10 minutes of warm up on their initial pair of assigned lanes. Participating bowlers ARE NOT allowed to practice or bowl on any lanes on the day of the tournament other than tournament play and the warm-up as described here.
- Any disputes must be reported no later than 30 minutes after the completion of the 3-games. The tournament management shall be the final authority in the event of disputes in accordance with tournament and USBC Rules. All decisions of the Tournament Management are final

***Please note: No youth bowlers permitted. Bowlers cannot be currently bowling on a junior league or a high school bowling league.**
